### **Sanctions of Violation Article 113**

#### **Law No. 28 of 2014 concerning Copyright**

- (i) Every person who without the right to violate economic rights as referred to in Article 9 paragraph (1) letter i for commercial use is sentenced to a maximum imprisonment of 1 (one) year and/or a maximum fine of Rp 100,000,000 (one hundred million rupiah).
- (ii) Any person who without the rights and/or without permission from the Creator or Copyright Holder committed a violation of the Creator's economic rights as referred to in Article 9 paragraph (1) letter c, letter d, letter f, and/or letter h for use in terms of use Commercial is sentenced to a maximum imprisonment of 3 (three) years and/or a maximum fine of Rp. 500,000,000.00 (five hundred million rupiah).
- (iii) Any person who without the rights and/or without permission from the Creator or Copyright Holder committed a violation of the Creator's economic rights as referred to in Article 9 paragraph (1) letter a, letter b, letter e, and/or letter g for use in terms of use Commercial is sentenced to a maximum imprisonment of 4 (four) years and/or a maximum fine of Rp 1,000,000,000.00 (one billion rupiah).
- (iv) Every person who meets the elements referred to in paragraph (3) which is carried out in the form of piracy, sentenced to a maximum imprisonment of 10 (ten) years and/or a maximum fine of Rp. 4,000,000,000.00 (four billion rupiah).
